 - Medical documentation (if applicable)
 - All reports and documentation for Inclusive support (if applicable)
 - Family law documentation (if applicable)
 - Passport/ Visa (if applicable)

Once your in-catchment status is verified or your reason for applying out of catchment is approved, you will be sent an email with the enrolment application to be completed, and an enrolment interview will be scheduled for you to attend with your student.
